# What Will My Child Do?

- Your child will **watch an interactive video** and **make choices during an online activity**.
  - Your child will be assigned to different groups that will effect the scenario they are asked about.
  - They will answer questions about how they think about fairness.
- Your child will proceed at his/her own pace the whole time.
- Sessions last no longer than **15 minutes**.
- Parents must remain present for the duration of the session.

# Webcam Recording

- Your child's responses will be video-recorded via your computer's **webcam** and **microphone**.
- You may review the recorded video after and request that all or any portion of the tapes be destroyed.
- All video data will be sent securely to our lab. No one outside the lab will have access to it.
- **No identifying information** will be linked to your child's recording.

# Use of Data



- Recordings from this study will be stored on a **password-protected** server.
- Your child's responses will be **linked to the information** you provided when registering your child for PANDA, including their birthday, grade in school and zip code.
- At the end of your session, you will **select a privacy level.**
- Unless otherwise specified in your privacy settings:
  - Information not containing identifiers may be used in future research, shared with other researchers, or placed in a data repository without your additional consent
  - Video clips will not be shared
  - Personal information will not be published

# Participation

- Your and your child's participation are **entirely voluntary**.
- You may choose to stop the study session at any point without penalty.
- Please pause or stop the study if your child becomes fussy.

# Compensation

- For participating in this study, your child will receive a **\$10 Amazon gift card**.
- Compensation for this study is restricted to:
  - Children within the specified age range (ages 5-8)
  - The first time a particular child completes this study
  - Children for whom we have received data indicating their progress **AND/OR** an uploaded video

- These studies will (hopefully!) **advance our understanding** of how children think about fairness.

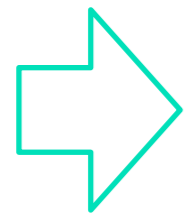




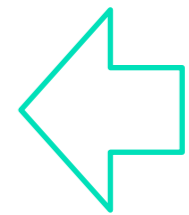
